- The Educational agency shall submit the Annual Administration Report in the prescribed proforma as prescribed in G.O.Ms.No.1 Education, dated:01.01.1994, to the competent authority for every financial year by 30<sup>th</sup> of September at the latest. Such Report shall be supported by the audited statement of accounts of the school duly audited by a Chartered Accountant.
- The School Management shall upload their school information in the web site of the State School Education department including their fees details and other required information useful to the parents.
- The Management should follow the provisions of the Telangana Education Act, 1982; G.O.Ms.No.1, Education (PS.2) Department, dt.01.01.1994, as amended from time to time and Compulsory Teaching and Learning of Telugu as per the provisions of the Act No.10 of 2018, dt.30.03.2018, which came into force from 02.04.2018 and the connected Rules to this Act issued vide G.O.Ms.No.15, School Education (Prog.II) Department, dt:01.06.2018. The Government have also prescribed the books to be introduced for Classes I and VI which have to be followed for the Compulsory Teaching & Learning of Telugu language as per this Act 10 of 2018 & the connected Rules.

Permission/Extn.Temporary Recog. has been accorded to the Class (s)VI to X (E.M.) for the year 2005-2006 to 2009-2010 in respect of Hi-tech Modern School, Swarnadhamnagar, Old Bowenpally, Dist.Ranga Reddy in the orders first cited. The inspecting authority i.e., Dy.E.O.,Malkajgiri, Ranga Reddy Dist. has submitted the report for provisional recognition to the school for the years 2010-2011 to 2019-2020 vide letter third cited. The Dist.Ednl.Officer,Ranga Reddy Dist. has verified the application for provisional recognition with reference to the inspection report of the Inspecting officer and also with reference to the conditions laid down in the permission order/previous recognition orders and G.O Ms.No.1Edn, (PS.2) Dept. dt.01.01.1994 and submitted a report in his letter 4<sup>th</sup> cited.

After careful examination of the references cited and the conditions prescribed in G.O. Ms. No.1/Edn, (PS.2) Dept, dt.01.01.1994 the Regional Joint Director of School Education, Hyderabad hereby accorded Provisional Recognition to Class(s) VI to X (E.M.) for the year 2010-2011 to 2019-2020 in respect of Hi-tech Modern School, Swarnadhamnagar, Old Bowenpally, Dist. Ranga Reddy subject to fulfillment of conditions as detailed below:

01. That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time.
02. That the educational Society shall serve the needs of locality more particularly.
03. That the institution shall adopt the curriculum and syllabus prescribed from time to time by the state Govt.
04. That the school timings, vacations and mid-term holidays shall be as prescribed by Govt.of A.P. from time to time.
05. That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No. 103 Edn (PS), dt.05-08-2005.
06. That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn (PS), dt.26.02.98.
07. That the records/accounts shall be furnished to the D.E.O every year by 31<sup>st</sup> March, at the latest.
08. That the list of governing body shall be furnished to the DEO every year.
09. That the pay structure/fee structure fixed by the governing body shall be got approved by the DEO every year.
10. That all the conditions prescribed in G.O.s as referred above in reference and other orders which are not specified in this order shall complied with.
11. That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior permission of the competent authority, Action will be initiated if any deviation of the orders.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf. The recognition orders now given is confine to this school only and no branch shall be covered with this orders.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide, the necessary material even if it costs more than the deposit amount.
18. Admissions should be made on the basis Record sheet issued by the Private Recognised/ZP/ Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bona-fied candidate.
19. The Edn.Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.6<sup>th</sup> cited.
20. The above E.T.R. is granted subject to condition that, if it is found later that the school has not fulfilled the prerequisite condition under the A.P. Education Act 1982 and reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.

2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed by Government from time to time.
4. The school timings, vacations and mid-term holidays shall be prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall appointed as per the staff pattern.
6. That the results of the institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the DEO, every year by the end of academic year at the latest. structure/fee structure fixed by the Governing Body shall be got approved in the order shall be complied with.
8. That all the conditions prescribed in the GO's and other orders which are not specified in the order shall be complied with.
9. That the school shall not be closed without giving notice both to the parents/ DEO and competent authority.
10. That the list of Governing Body shall be furnished to the DEO every year.
11. That the pay authority at-least six months before.
12. That the school shall not be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of provisional recognition immediately in advance i.e., at-least six months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior renewal.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
16. That recognition is accorded to open the school premises in the locality and there shall not be any change to the premises or locality.
17. The society shall provide, the necessary material even if it costs more than the deposit.
18. Admissions should be made on the basis Record Sheet issued by the Private recognized ZP/Govt./Aided schools only. TCs/Certificates issued by the Secretary, DCEB as Bonafied candidate.
19. The Educational Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Government from time to time by the end of April every year as per GO 3rd cited.
20. The above ETR is granted subject to conditions that, if it is found later that the school has not fulfilled the pre-requisite conditions under AP Education Act 1982 reported by State Level Inspection Teams and Vigilance Committee, the ETR now being granted is liable to be withdrawn at-once.
21. That the Educational Society shall follow the Examination schedule as per the time table issued by the DCEB and should conduct DCEB Question papers for Quarterly, Half-yearly, Annual and Pre-final examinations.
22. That the Educational Society should follow school timings as prescribed by Government, in school academic calendar.
