1. **NAME OF THE ASSOCIATION** The name of the Association is Haragopal Educational Society, which shall be written in Marathi in the Association.

2. **LOCATION OF THE OFFICE** The principal office of the Association shall be situated at S. S. Marathwada Nagar, Opposite Dadasaheb Farm Old B. W. S. P. Office, (M. S. Road, Mumbai - 400 011).

3. **AIMS & OBJECTS** The aims for which the Association is established are to ensure the smooth running of the activities of the association for which it is established and shall also include the following:

- i) To establish and manage educational institutions such as schools, primary, upper primary, high school and colleges.
- ii) To collect and obtain all information on matters affecting the members, make representations to the various authorities and to appear before any authority in the interest of protection and betterment for the educational institute and to publish and circulate the information collected and any other matter in members and other.
- iii) To communicate with the Government local and public authorities, other educational societies in India and other countries and with individuals on all subjects.
- iv) To raise funds for carrying on the activities of the Association.
- v) To support and/or oppose and take necessary all and every action including legal recourse to represent, defend and support/oppose any such move, legislation, treaty or other concerned measure, imposition or enactment for the protection of legitimate rights, interest and work of the Society.
- vi) To acquire by purchases, donations, gifts or otherwise any movable and/or immovable properties, rights, interest and titles in the interest of the Association and its objects and to manage them.
- vii) To do all things incidental and conducive to the attainment of the objects of the Association.

MEMORANDUM OF ASSOCIATION  
OF  
HARAGOPAL EDUCATIONAL SOCIETY

- 1 **NAME OF THE ASSOCIATION:** The name of the Association is Haragopal Educational Society which shall hereinafter be referred to as Association.
- 2 **LOCATION OF THE OFFICE:** The registered office of the Association shall be situated at Swarnabhama Nagar, Opposite Dairy Farm, Old Bowenpally, Secunderabad - 500011.
- 3 **MEMBERSHIP:** Any person firm company can become the members of the association by paying the requisite membership fee.
- 4 **MANAGEMENT:** The management of the Association shall rest in the executive committee of the Association consisting of a President, Vice-President, Secretary, and Treasurer and two committee members.

The general body shall elect all members of the committee.

The Members of the First executive committee shall be as follows:

The first executive committee and its members including office bearers shall remain in office up to the conclusion of the first Annual General Meeting, and they are eligible for re-election.

- 5 **TERM OF OFFICE OF THE COMMITTEE AND MEETINGS:** The Members of the committee shall hold office for a period of two years from the time of assumption of office. Any elected member of the committee may at any time resign from his office by sending a letter of resignation to the President of the Association. But such resignation shall take effect only from the date on which it is accepted by the executive committee.

ii. Meeting of the executive committee shall be convened by the Secretary once in three months or often if necessary for conducting the business of the association. In special circumstances the President may however convene a meeting of the executive committee. The President shall call for a meeting of the committee a month after the receipt of requisition in writing signed by at least 2/3 of the members of the committee for the meeting of executive committee. The quorum shall be 1/3 of the strength of the committee members. All questions before the committee shall be decided by majority votes.

iii. Should there be an equality of votes, the president or other presiding member shall have a casting vote. No member of the committee shall be present at a meeting when any matter in which he is personally interested is being discussed.

#### 6. ADMINISTRATION:

The entire administration of the association shall vest in the executive committee. Among the powers of the committee shall be -

- i. To authorise the president to open a bank account with any scheduled or nationalised bank which shall be operated by the President and Vice President as second signatory or in his absence by Secretary.
- ii. To scrutinize and put up the annual budget to the General Body.
- iii. To prescribe or regulate from time to time the strength of office and establishment and their salaries and allowances and to regulate their works.
- iv. To submit to the General Body the Annual Report and the statement of account.
- v. To make the arrangements for the efficient supervision of the employees association.
- vi. To appoint, suspend, remove or dismiss or otherwise deal with the employees of the association in accordance with service rules and code of conduct.
- vii. To arrange, to maintain such accounts and registers.
- viii. To institute, conduct, defend, compound, compromise or abandon legal proceedings by or against the association.
- ix. To transact all other business incidental to the administration of the association.
- x. To fix the amount and nature of security, if any to be given by the office establishment.

8. **DISQUALIFICATION OF THE MEMBERS OF THE COMMITTEE:** No person shall be eligible for being chosen as and for being member of the committee if he is - a defaulter to the association for a period of three months or more in respect of the membership fee or any other amount that is payable to the association.
9. **SERVICES OF THE MEMBER TO BE GRATUITOUS:** The services of the members of the committee shall be gratuitous.
10. **POWERS OF OFFICE BEARERS:** Subject to such resolutions as the committee may from time to time pass in this behalf, the several officers of the committee shall have the powers mentioned below.

**President**

- The president shall exercise general control and supervision over the affairs of the association and the work of its officers. He shall with approval of the committee make arrangements for the safe custody of cash and other properties of the association and frame suitable rules for this purpose. He shall be also have power to appoint the members of the establishment as well as remove them and preside over the general body, the committee and other sub-committee.
- The president shall exercise the powers delegated to him by the committee and may subject to the approval of the committee delegate any of its power and duties to the vice-president or in his absence to any committee member for a specified period and may with draw any power so delegated.

**Vice President:** Whenever the president is obliged to absent from head quarters or illness or any other cause, the vice-president shall exercise the powers and perform the duties of the president.

**Secretary**

- The Secretary shall be responsible for the general administration of the association subject to the control of the president.
- The secretary shall
  - Have custody of all account books and the registers of the association.
  - Be an officer to sue or be sued on behalf of the association all the bonds in favour of the association shall be in the name of his office.

- c. Have power and on behalf of the Association to operate Association's accounts jointly with its president or any other authorized person for the purpose and subject to such direction and limits as may be laid down by the committee and also to pledge, endorse and transfer securities, stocks, bonds, debentures and other securities standing in the name or held in the Association to sign, endorse and to sign all receipts and other documents connected with the business of the Association.
- d. Have also power to submit to the directions of the committee to accept deposits and to carry on general transactions within the framework of these by-laws.
- e. Arrange for holding of the meetings of the committee and general body.
- f. Attend every meeting of the committee.
- g. To do all that is necessary for carrying on generally the day-to-day administration of the Association.
- h. Incur expenditure on contingencies within the budget allotment and within the limits prescribed by the Association in respect of each of them.
- ii. Whenever the secretary obliged to absent himself from his office by reason of his absence from head quarters or any other cause the president shall exercise the powers and perform the duties of the secretary.

General Body The ultimate authority in all matters relating to the administration of the society shall rest in the general body. The general body shall not however interfere with the power of the committee in respect of matters delegated to it in the by-laws. The general body shall deal with the following among other matters:

- i. Election and removal of the members of the committee.
  - ii. Consideration of the audit report and the annual report and review of the financial position of the Association.
  - iii. Amendment to by-laws.
  - iv. Approval of the annual budget of income and expenditure.
11. **USE OF PREMISES:** The Association shall not use or allow to be used the premises that is provided by the promoters for all common use of the office or any purpose other than business of the Association.

12. **OFFICIAL YEAR:** The proposed financial year of the association shall commence from 1<sup>st</sup> April and shall end on 31<sup>st</sup> March.

13. **AUDIT OF ACCOUNTS:** The accounts of the association shall be audited by the Chartered Accountant appointed by the general body at a meeting. However, the first auditor and the auditor shall be appointed by the managing committee in its first office till the conclusion of the first annual general meeting.

14. **FUNDS:** The association shall raise funds from its members.

a. **Admission fee:** Every member shall, at the time of the admission as member, contribute a sum of Rs.2000/- towards initial membership fee.

b. **Subscription:** Every member shall contribute towards each subscription a sum of Rs.100/- by him during the continuance as member.

The funds of the Association shall be spent only for the attainment of the aims and objects of the Association and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.

15. **AMENDMENTS:** No amendments or alterations shall be made in the memorandum or rules of association unless it is voted 2/3<sup>rd</sup> members present at the special general body meeting convened for the purpose and confirmed by 2/3<sup>rd</sup> of the members present at a special meeting.

16. **WINDING UP:** In case the association has to be wound up, the property and funds of the association shall be transferred or paid to some other institutions with similar aims and objects.

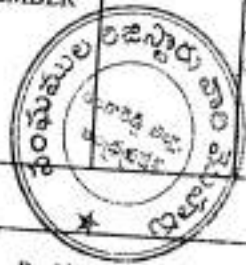
